Report of ICC Region VII Activities

ICC Region VII met March 21 -22, 2013 in Hagerstown, Maryland. The following is a summary of the meeting highlights:

- Shaun Strasbaugh led the group through a series of code changes to be heard at the Committee Action hearings for the Group B codes in Dallas, Texas. The Region reviewed and took positions on 69 individual code changes.
- Steve Jones, ICC Vice President, reviewed the proposed agenda for the ICC Annual meeting to be held in Atlantic City, New Jersey.
- Steve Jones and Guy Tomberlin, ICC Vice President and Secretary/Treasurer respectively, gave a report on ICC activities.
- A bylaw change to create an honorary membership status was approved

Attached are the draft notes from the meeting (minutes unavailable as of this writing) which elaborate on the highlights listed and contain other items of interest. The next scheduled meeting is September 19 -20, 2013 at Hagerstown, Maryland. This meeting will be important as the Region VII will take positions on code changes scheduled to be heard at the Public Comment hearings.

# **DHCD Report**

# **Sandi Morris and Cindy Davis**

## **Code Academy:**

- Multi-day Commercial Energy program required for certification is nearing completion and scheduled to pilot in May.
- ➤ Beginning with the Fall Semester, many VBCA courses will offer single occupancy lodging at no additional fees. Course descriptions will indicate the availability of single room lodging at no extra fee.
- New certification regulations were finalized and were approved by the CSC on March 25.
- > Joe McCoy has left DHCD to accept a position in Michigan (near his granddaughter!), we ask for your patience as we are short staffed and are in the recruitment process.
- New Code Connection blog is being developed and we hope that everyone will subscribe to it and that you will utilize it as yet another source of information and communication from DHCD to our client groups.

# **State Building Codes Office**

- > Overview of the code update cycle.
  - o Approximately 97 changes have been approved by the CSC thus far
  - These will be incorporated into the base documents and will be before the full Board of Housing for consideration on May 20
  - Deadline for code changes in July 1
  - Will likely have another workgroup at the end of August
  - Anticipate public hearing September 23
  - Tentative final approval of all regulations December 16 after that it's in the hands of the new Governor
  - Emory will post new schedule after May 20 Board meeting
- > New technology is being used to distribute information to our stakeholders, will reduce spam emails and size limit issues on personal emails.
- > DHCD will begin negotiations soon (June) with ICC to for the Virginia Codes. In addition to the printed books, please be thinking about what types of new products would be helpful in your day to day jobs and send an email to Cindy.
- > Some internal changes have been made a DHCD in an effort to streamline and improve code opinions. All will now be tracked and used for improving consistency, monitoring for educational opportunities and tracking problem areas for future code cycles.

# Highlights are as follows:

- Reorganizes and reformats the Association's Constitution and Bylaws.
- Clarifies the Association's membership categories.
- Simplifies meeting timeframes and proposes a reduction in the number of required meetings per year.
- Includes quorum requirements for Membership Meetings.
- Clarifies term limits of Officers and Directors.
- Authorizes BOD's to conduct business through electronic means.
- Updates list of non-voting, ex-officio Board members.
- Individual duties of Board members to be listed in a separate Board-approved job description policy.
- Documents the Association's awards categories.
- Documents the Association's Code Hearing Scholarship Program.
- Includes the Association's Code of Ethics.
