Secretaries Report: Minutes from the October 12, 2012 BOD Meeting were approved.

Executive Secretary Report: *Please see attached report.* Geary pointed out the rising costs for mailing new member packets and the group felt including the annual yearbook was worth the costs for mailing and not to eliminate it when mailing out new packets.

Codes and standards council application closed on February 11th. April hearings schedule will be out soon.

DHCD Report: Emory applauded VPMIA for all the efforts put into the 2012 USBC process. We have made significant progress getting gray water from the green code into The 2012 USBC; the swimming pool code will be part of the 2012 USBC as well as marina requirements for plumbing fixtures. Also addressed domestic appliances used for domestic purposes in commercial buildings. Emory stated we (VPMIA) have addressed everything we were tasked with and then some. Emory stated that DHCD will assist with scholarship monies for members wanting to attend the hearings in Dallas this April.

DPOR Report: No report-(President Bladen encouraged all to contact DPOR and comment regarding the possible elimination of PMG CEU's.)

BCACC Report: (Emory) Met and approved some draft regulations however I do not have the actual report. The development of 2012 code change training to start this summer. **(Rick Witt)** Just a reminder that if your last name ends with the letters N-Z your DHCD CEU's are required by the end of May.

By Laws/Parliamentarian: *Please see attached draft.* Paul Rimel handed out a copy of the draft of the bylaws rewrite thru Article V. I (Skip) had stated I thought it was not fair for the Secretary/Treasurer duties to transfer in the middle of the SOI. Bob Adkins stated that according to the current bylaws (Article IV, Section 3-b) we are doing the changing of the officers at the wrong time as the current by-laws state: The officers stay in place thru the close of the SOI which most agreed was at the end of the last day which is currently our General Membership Meeting. Geary Showman stated the SOI ends at the end of day three. Rick Witt stated the committee will define when the SOI starts and ends. Richard Grace pointed out that the general membership meeting starts as Part 1 on the 2nd day and Part II is on the 3rd day (currently) however it is still one meeting therefore the end of that meeting is the close of the SOI.

The bylaws committee is proposing a Board of Directors Job Description Policy.

Nominations: (Bane Compton) I have personally spoke with all the present Directors and Officers and asked if they would be willing to serve as next year's VPMIA upcoming Officers and Directors. They all said they would be proud to.

I have urged the Director at Large and Four District Directors to set up training in their districts. Dustin has training scheduled for Feb 27th and 28th. I have an agreement with an online DPOR training provider to simply link from our site to his and every time someone clicks from our site we would generate \$5.00 for plumbing and HVAC, and \$3.00 for gas. Startup cost for VPMIA would be nothing nor would we be required to be involved in any portion of entering DPOR data, maintenance, or phone calls however this was not agreed upon by the group so I will break my ties with this firm.

PMG Committee: Richard reported code changes for the IRC are due out on March 11th and a code committee meeting will be held right after that, workgroup meetings with DHCD are continuing as well.

The Board authorized staff to proceed with the initiative to increase participation in ICC's core function: Code Development. Testing of the online Governmental Consensus Vote will occur in October in Atlantic City at the 2013 Public Comment Hearings. After system and process adjustments the 2014 Cycle for the IgCC will be a binding Beta test for the entire cdp ACCESS process.

LEGISLATIVE COMMITTEE REPORT
(Updated 2-14-13)**

HB 1436 Status- Failed to report from committee

(No Position) Mechanics' lien' notice; claimant must send to property owner 30 days before filing.

Chief patron: Purkey

Summary as introduced:

Mechanics' lien notice. Provides that any person intending to perfect a mechanics' lien against a one-family or two-family residential dwelling unit must send the mechanics' lien agent designated on the building permit or, if no agent is designated on the permit, the property owner written notice of his intention at least 30 days before filing the memorandum of lien with the clerk of the court. The bill also provides that if no mechanics' lien agent is designated on the building permit, the permit shall contain the name and mailing address of the property owner.

HB 1511 Status- Tabled in committee

(No position, the patron decided to ask for the bill to be laid on the table before we took a position) Assisted living facilities, licensed; access to temporary emergency electrical power source.

Chief patron: Hope

Summary as introduced:

Assisted living facilities; access to temporary emergency electrical power source. Requires the Board of Social Services to include in regulations governing licensed assisted living facilities a requirement that each licensed assisted living facility with six or more residents have a temporary emergency electric power source on site and be able to connect to and utilize such temporary emergency electrical power source for the provision of electricity during an interruption of normal electrical power supply, in order to protect the health, safety, and welfare of residents and ensure the continued delivery of vital services for residents.

HB 1574 Status- Passed House with amendment regarding maintenance. Passed by (Died) in the Senate.

(No Position) Uniform Statewide Building Code; enforcement by towns.

Chief patron: Minchew

Summary as introduced:

Uniform Statewide Building Code; enforcement by towns. Provides that if any town does not elect to enforce the Uniform Statewide Building Code, then such enforcement shall be the responsibility of the county in which the town is situated. The bill also provides that the enforcement by the county shall be with equal dignity as the county does in unincorporated areas of the county and no agreement between the town and the county shall be required as a prerequisite for the county to perform this obligation. The bill contains technical amendments.

Per Del. Minchew. There are some counties who do not let their building code official work in town where they don't have an additional agreement (payment). He disagrees with this since the town is paying for this service and shouldn't have to pay twice without additional agreements.

HB 1589 companion to SB744 Status- Passed House with modified lien holder language. Reported from the Senate committee with amendments.

(Support, provides additional options to the locality and reduces waiting times for publishing notices) Demolition of a derelict nonresidential structure with consent.

Chief patron: Minchew

Summary as introduced:

Demolition of a derelict nonresidential structure with consent. Authorizes a locality to demolish or remove a derelict nonresidential structure and to file a lien against the property for the cost of the demolition or removal. The bill requires the locality to obtain the written consent of the property owner for such demolition or removal and prohibits the use of the authority to remove a building that is located in a local historic district or individually designated as a historic landmark.

HB 1645 Status- Passed House and Senate.

(Support, makes tradesmen license term consistent with the building code cycle) Board for Contractors; tradesmen licenses. Board for Contractors; tradesmen licenses.

Chief patron: Tata

Summary as introduced:

Board for Contractors; tradesmen licenses. Provides that licenses for tradesmen shall expire three years from the date of issuance by the Board for Contractors. This measure is an attempt to sync changes to the Uniform Statewide Building Code, which are on a three-year cycle, to the expiration of a tradesman license, which is currently every two years.

HB 1722 Status- Tabled in committee.

(Oppose, this would be difficult to comply with as it refers to all steps, permits and processes to obtained permits must be documented) Facilities; assistance and documentation to person seeking business license, etc.

Chief patron: Head

Summary as introduced:

Assistance and documentation required from localities. Provides that in any instance in which a person is seeking a business permit, a license, or an application for any similar local government approval from a locality, the locality shall provide documentation and instructions that outline all steps necessary to obtain the permit, license or approval. The locality shall also specify any further permit, license or other approval that may be required to complete the original project or business activity and shall disclose the expected time required by the locality for the completion of each step of the process to obtain the license, permit or other approval.

HB 1744 Status- Passed House with minor amendments and passed Senate.

(No Position) Grass cutting; written notice to property owners for purposes of nuisance abatement.

Chief patron: BaCote

Summary as introduced:

Cutting of grass; nuisance abatement. Provides that one notice per incident or per growing season shall constitute reasonable notice to property owners for purposes of nuisance abatement.

The credit would equal 35 percent of the installed cost of the system and only the ultimate consumer or user of the system would be allowed to claim the credit. The credit would not exceed (i) \$500,000 for solar energy systems placed in service for any purpose other than use for a single-family dwelling or placed in service and having in excess of 120 square feet of collector area or (ii) \$2,500 for every other solar energy system placed in service.

The credit would be required to be claimed in three equal annual installments for solar energy systems serving other than a single-family dwelling. The credit would expire and no further credit could be claimed if the solar energy system is disposed of, taken out of service, or moved out of the Commonwealth during any of the installment years. Any unused credit could be carried forward for three taxable years. The credit would sunset in 2018.
