Attached is a summary of the 75 vs 85 share of federal disaster funding included in the recently adopted federal budget. You may have seen a news release from ICC related to how current code adoption could affect the amount of federal disaster dollars available after a disaster. Current code adoption is one factor (all five are listed below). FEMA is to develop weighted criteria within one year that will determine how much above 75% (up to 85%) disaster funding will be available to a community

Criteria:

- 1. adoption of an approved mitigation plan;
- State and Tribal investments in disaster relief, insurance, and emergency management programs;
- Adoption and enforcement of the latest published editions of building codes and standards that protect the health, safety and general welfare of a buildings' users;
- 4. Participating in the Community Rating System; and
- 5. Funding for mitigation projects or granting tax incentives for risk reduction projects.

By compiling the complete text of the 2018 IECC and ANSI/ASHRAE/IES Standard 90.1-2016, this joint resource offers users a convenient publication that contains the latest requirements for energy efficiency in a single volume to provide the information needed to achieve optimal energy conservation in both residential and commercial construction.

Summary of Budget Bill Provisions

Bi-Partisan Budget Act of 2018 – Impact on Robert T. Stafford Disaster Emergency Assistance Act Federal Cost-Share Adjustments for Repair, Restoration, and Replacement of Damaged Facilities. Signed by President on February 9, 2018. Now Public Law 115-123.

SUMMARY:

On February 9, 2018 Congress passed, and the President signed, a bi-partisan budget agreement which raises the cap on defense spending from \$603 billion to \$629 billion in 2018, and from \$616 to \$647 in 2019. This would increase the Federal post disaster cost-share from 75% to as high as 85% for State and Tribal governments that have made investments in disaster readiness by recognizing such measures as: adoption of a mitigation plan; investments in disaster relief, insurance, and emergency management programs; encouraging the adoption and enforcement of the latest building codes; facilitating participation it he Community Rating System; and funding mitigation projects or giving tax incentives to projects that reduce risk.

FEMA will issue guidance to the States. As this legislation just recently passed and was signed into law on the 9th we may have to wait a few weeks before further direction is provided by the Agency. We will stay on top of this and will keep our Members informed.

The BPBA means continuation budgets to most agencies, with more to FEMA due to the disaster funding. More to HHS for social services spending. Here is the other factor: Because agencies that don't know what their budget will be still have to operate, they have to make assumptions. Once the President proposes his budget, even though it will likely not be approved, the agencies can't assume they will get more than what the President proposes in his budget, even if it is clear that Congress might appropriate more.

PROVISION DETAILS:

Section 406(b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C 5172 (b)) was amended provide incentives increasing the post-disaster Federal cost-share with State and Tribal governments share from 75% to 85% based on FEMA guidance.

The guidance shall consider measures and investments weighted and based on FEMA's assessments of eligible actions which include:

- adoption of an approved mitigation plan;
- State and Tribal investments in disaster relief, insurance, and emergency management programs;
- adoption and enforcement of the latest published editions of building codes and standards that protect the health, safety and general welfare of a buildings' users;
- 4. participating in the Community Rating System; and
- 5. funding for mitigation projects or granting tax incentives for risk reduction projects.

Within one year, through guidance, FEMA will detail and provide weighting for the five measures. FEMA is also required to provide House and Senate committees a report containing analysis of the Federal cost shares paid.

LEGISLATIVE LANGUAGE:

"(3) INCREASED FEDERAL SHARE.—

- "(A) INCENTIVE MEASURES.—The President may provide incentives to a State or Tribal government to invest in measures that increase readiness for, and resilience from, a major disaster by recognizing such investments through a sliding scale that increases the minimum Federal share to 85 percent. Such measures may include—
 - "(i) the adoption of a mitigation plan approved under section 322;
 - "(ii) investments in disaster relief, insurance, and emergency management programs;
 - "(iii) encouraging the adoption and enforcement of the latest published editions of relevant consensus-based codes, specifications, and standards that incorporate the latest hazard-resistant designs and establish minimum acceptable criteria for the design, construction, and maintenance of residential structures and facilities that may be eligible for assistance under this Act for the purpose of protecting the health, safety, and general welfare of the buildings' users against disasters;
 - "(iv) facilitating participation in the community rating system; and
 - "(v) funding mitigation projects or granting tax incentives for projects that reduce risk.
- "(B) COMPREHENSIVE GUIDANCE.—Not later than 1 year after the date of enactment of this paragraph, the President, acting through the Administrator, shall issue comprehensive guidance to State and Tribal governments regarding the measures and investments, weighted appropriately based on actuarial assessments of eligible actions, that will be recognized for the purpose of increasing the Federal share under this section. Guidance shall ensure that the agency's review of eligible measures and investments does not unduly delay determining the appropriate Federal cost share.
- "(C) REPORT.—One year after the issuance of the guidance required by subparagraph (B), the Administrator shall submit to the Committee on Transportation and Infrastructure of the House of Representatives and the Committee on Homeland Security and Governmental Affairs of the Senate a report regarding the analysis of the Federal cost shares paid under this section.
- "(D) SAVINGS CLAUSE.—Nothing in this paragraph prevents the President from increasing the Federal cost share above 85 percent."

Tall Wood Structures: Group A Proposals

Kenneth Bland, P.E. (Based out of Leesburg office of American Wood Council (AWC))

Goal of Presentation: Explain proposed changes to the Building Code regarding tall wood buildings. Changes are part of Group A.

- A Tall Wood Ad hoc committee formed in 2015 when AWC approached ICC Board. What was compelling to the board was that a number of jurisdictions had been approached about building a tallwood buildings.
- This is all in mass timber, solid wood elements.
- Cross-laminated timber (CLT) is just one type of material for tall wood buildings. Includes other
 mass timber and solid wood elements.
- Committee Scope
 - Explore the building science of tall wood buildings
 - Investigate feasibility
 - Take action on developing code changes for tall wood buildings
- 15 members on the committee composed of...
 - Industry Reps
 - Building and Fire Code Officials
 - Architects and Engineers
 - Fire Protection Experts
 - Other stakeholders
- 4 working groups
 - Codes working group, establish heights and areas
 - Fire established the testing scenarios. They have now tested them. Sean DeCrane, Chair
 - Structural
 - Definitions and Standards
 - 82 major issues examined
- University of British Columbia built a dorm called "Brock Commons" at the Vancouver, Canada campus. It is a glu-lam mass timber building at 18 stories. It is the first big project in North America and started the movement.
 - It features a pre-fab envelope, concrete topping on floors, three layers of gypsum board on ceiling and columns
 - The Vancouver Fire and Rescue Service was initially skeptical, but now really impressed by it (from Fire Engineering in January 2018)
- Fire Testing
 - Built a residential apartment that was typical. Two story building and was conducted indoors
 - Conducted at NIST or ATF?
 - Loaded up with furnishing to have a high fuel load. 95 percentile of Group R.

- 20 minute rated door from apartment to corridor
 - To note, the 20 minute door performed very well.
- 90 minute rated door to stairwell
- Up to 12 stories some exposed CLT's allowed and at 18 stories there are no exposed CLT
- 5 tests were conducted
- Code Proposals Summary:
 - Type IV-HT to stay the same
 - Introduce Type IV-C new proposal
 - Introduce Type IV-A new proposal (270')
- AWC.org They have regular webinars.
- Adhesive tests are looking for a consistent char-rate
- Ouestions from the audience:
 - How do you handle rehabilitation after a fire?
 - How do we deal with synthetic, plastic materials? Burning plastic has a thick black smoke and wood smoke is a gray smoke. What type of furniture was in the test home?
 - Is a special inspection required for the tall wood buildings, recommended by the committee? Yes, there are special inspections required and built into chapter 17.
- Other buildings:
 - Portland, Oregon has one under way. The performance is equivalent to Type I-B.
 - Building proposal in NYC was denied.

Kelly Duggins has joined the Code Academy as a training coordinator. He will be managing the certification application process and class registrations. Vernon Hodge will be retiring on May 4.
- Bill Shelton, agency Director for 22-years retired in January and Erik Johnston has been appointed by Governor Northam as the new Director. Erik worked for VACO as well as NACO and had the opportunity to work for Bill as Chief Deputy for a year prior to being appointed. Also new at DHCD is Courtney Dozier who has been appointed as Chief Deputy for the Agency and Jay Grant who is the new Deputy Director of Community Development. Jay came from HUD and is very familiar with the agency's grant programs.
- Related to Community Development, we are developing two webinars for that Division, one on the Maintenance Code and one on the Rehab Code. The webinars are geared to Main Street Programs, chambers and elected officials so that they become aware of the tools available to them for and during revitalization opportunities.
- Also in the works is a manufactured home training program that will be presented in Southwest Virginia at the end of May. Another installation/licensing training is being developed for dealers and industry. Anyone interested in this program should contact Jeff Brown for additional information.
- Final regulation phase of the 2015 Code Change Cycle is nearing conclusion. The BHCD approved the regulations on Monday, October 16. Once approval to publish is received, the regulations will be published in the Virginia Register for a public comment period. If a petition is received it must be published in the register for another comment period. The BHCD will then rule again on the regulations, either affirming or changing their original approval. We are in a holding pattern with publication and training. Although the code update training is moving forward and will be tweaked as necessary. We do not have the same flexibility with the publications. Effective date at this point is unknown.
- State Technical Review Board Currently there are four pending cases.
- The 2018 VAGHC is at the Hyatt Regency Crystal City in Arlington, VA November 14-16, 2018.
- DHCD is in the process of obtaining electronic versions of every code in effect in Virginia since 1973. It is anticipated that the jurisdictions will receive an electronic version of a pdf to download. That will come directly from ICC and should be sent out within the next month.
- BSM student Scholarship

VBCOA, VPMIA, and DHCD have partnered to offer the student essay scholarship to highlight Building Code Safety Month. The scholarship is open to rising or graduating high school seniors and current first, second or third year students of a two or four-year institution. This year's essay theme is Building Codes Save Lives and we are seeking a 1000-word or less essay that illustrates how building codes impact the student's individual and community safety. (Concluded 04-25-18) Thru- HB1607, HJ160, HR35, SB993, SJ84, SR17

The legislative committee met via conference call on January 22, 2018. Call participants were: Emory Rodgers, Dustin McLehaney (VPMIA), Mike Eutsey (R7), Jeff Brown (DHCD), Sam Sapienza (R2), Julie Walton (R6/chair), Ron Clements (R6/chair), David Beahm (R3); Art Berkley (R8) emailed comments.

HB 23 Status- Stricken
SB 20 Status- Signed by Governor, Effective July 1, 2018

No Position-

Chief patron: Webert (H), Chase(S)

Red Tape Reduction Commission; review of regulatory requirements; report. Creates the Red Tape Reduction Commission (the Commission) to develop and maintain a state regulatory baseline of all current state regulatory requirements, with the initial baseline to be completed by January 1, 2020.

HB 101 Status-Signed by Governor, Effective July 1, 2018

No Position-

Chief patron: Head

Board for Contractors; tradesmen licenses; expiration date. Provides that licenses for tradesmen shall expire three years from the date of issuance by the Board for Contractors. The bill requires the Board to sync the expiration date of a tradesman license, which is currently on a two-year cycle, to updates to the Uniform Statewide Building Code, which are typically on a three-year cycle.

HB 160 Status-Tabled in committee, Cole added to HB859 as co-patron

Support- This is similar to VBCOA bill HB 859. This bill provides enabling legislation that allows localities to enter into mutual aid agreements with other localities to provide assistance with building code enforcement services. We prefer HB 859.

Chief patron: Cole

Building code; mutual assistance. Provides that the governing body of any county, city, or town may enter into an agreement with another locality for the purpose of providing assistance on building code inspections, plan review, and permitting to a local building department in such locality.

HB 164 Status- Signed by Governor, Effective July 1, 2018

Support-This is a Newport News bill. This bill removes the requirement for permit applicants that are not required to be a licensed contractor to submit an affidavit. It cuts down on useless paperwork and bureaucracy.

Chief patron: Yancey

Board for Contractors; prerequisites to obtaining a building permit; elimination of affidavit requirement. Removes the requirement that a building permit applicant's written statement that he is not subject to licensure or certification as a contractor or subcontractor be supported by an affidavit. The bill contains technical amendments.

HB 192 Status- Signed by Governor, Effective July 1, 2018

Support- This bill provides for the health department to put regulations into place to approve rainwater as a residential potable water source.

Chief patron: Yancey

Rainwater and gray water; regulations. Directs the State Department of Health (the Department) to adopt regulations regarding the use of gray water and rainwater. The regulations shall provide standards for the use of rainwater harvesting systems. The bill also directs the Department to consider recognizing rainwater as an independent source of fresh water.

HB 229 Status- Died in committee SB 985 Status- Died in committee

No position-

Chief patron: Miyares (229), Wagner (985)

Hurricane and Flooding Risk Reduction and Bond Rating Protection Act of 2018; report. Establishes the Hurricane and Flooding Risk Reduction and Bond Rating Protection Act of 2018. Establishes the Commonwealth of Virginia as a nonfederal sponsor of hurricane and flooding risk reduction projects. There is also established the Virginia Hurricane and Flood Risk Reduction Authority (the Authority) and a board of directors (the Board) of the Authority.

HB 250 Status- Died in committee

No position-

Chief patron: Guzman

Virginia Fire Services Board; membership. Changes the membership of the Virginia Fire Services Board by removing a member of the Virginia Society of Fire Service Instructors and the State Fire Marshall and adding a fire service instructor and a non-legislative citizen member with fire service experience.

HB 256 Status- Died in committee

No Position- Expands the use of building departments to certify solar energy equipment for tax exemptions. This is expanding a current program that is rarely used and requires the building inspection departments to perform a task that is not building code enforcement related.

Chief patron: Guzman

Individual Income tax credit and property tax exemption for substantial-capacity solar equipment. Provides an individual income tax credit and a mandatory property tax exemption for substantial-capacity solar equipment. The bill defines "substantial-capacity solar equipment" and requires a taxpayer to obtain certification from his local building department that such equipment is eligible for exemption. Current law provides an exemption for a broader category of solar energy equipment, facilities, or devices; however, such exemption is permissive for localities and may be partial or full.

HB 391 Status- Continued to 2019 (Housing Commission will study)

Support- This is attempting to make it easier to get a search warrant based on complaints by citizens about a hoarding situation. We are working with the patron on language. Delegate Keam is looking to study this issue regardless of what happens with this bill.

Chief patron: Keam

Uniform Statewide Building Code; enforcement; inspection warrants; hoarding. Expands the circumstances in which an inspection warrant may be issued by a magistrate or court of competent jurisdiction to a local building official or his agent to include instances in which a local building department has received a complaint that a violation of the unsafe structures provisions of the Building Code exists due to documented prolonged and extensive hoarding

HB 399 Status- Signed by Governor, Effective July 1, 2018

Support- This will benefit the high school building code curriculum.

Chief patron: Keam

School boards; work-based learning experiences for students; notification. Requires each school board to implement a plan to notify students and their parents of the availability of internships, externships, apprenticeships, credentialing programs, certification programs, licensure programs, and other work-based learning experiences.

HB 523 Status- Signed by Governor, Effective July 1, 2018

No Position-

Chief patron: Lindsey

Board for Architects, Professional Engineers, Land Surveyors, Certified Interior Designers and Landscape Architects; membership. Adds two non-legislative citizen members to the Board for Architects, Professional Engineers, Land Surveyors, Certified Interior Designers and Landscape Architects. The bill also removes the provisions (i) requiring that the Council of Certified Interior Designers submit nominations for interior design members and (ii) specifying the particular members that must be present to achieve a quorum.

HB 594 Status- Signed by Governor, Effective July 1, 2018 SB 451 Status- Signed by Governor, Effective July 1, 2018

Support- This is a housing commission bill that expands the current drug blight statute to include sex crimes under title 18.

Chief patron: Carr (H), Dance (S)

Local government; authority to require abatement of criminal blight on real property. Authorizes any locality to enact an ordinance that requires corrective action to address criminal blight conditions on certain real property. The bill defines criminal blight to include conditions on real property that endanger residents of the community by the regular presence of persons using the property for controlled substance use or sale and other criminal activities, specifically commercial sex trafficking or prostitution. Current law allows local governments to enact an ordinance for taking action against a property owner with regard to illegal drug activity on such real property within the locality. The bill also provides a procedure for the locality and law-enforcement officials to secure inspection warrants for guest registries for real property operated as a hotel or motel or other transient lodging if the property is declared to be in a state of criminal blight. This is a recommendation of the Virginia Housing Commission.

HB 609 Status- Signed by Governor, Effective July 1, 2018

SB 391 Status- Signed by Governor, Effective July 1, 2018

SB 743 Status-Incorporated into SB391

Support- This is a housing commission bill that fixes a number of statutes that have old language. It also clarifies that local ordinances used to require smoke alarms should not be used to require upgrading an existing code compliant and functioning alarm.

Chief patron: Carr (H), Barker (391), Desteph (743)

Housing; installation and maintenance of smoke and carbon monoxide alarms. Creates a statewide standard for the installation (if not installed per USBC) and maintenance of smoke and carbon monoxide alarms in rental property. The bill requires a landlord to (i) install a smoke alarm without retrofitting the installation site and (ii) certify annually that smoke alarms have been installed and maintained in good working order in a residential dwelling unit pursuant to the Statewide Fire Prevention Code (§ 27-94 et seq.) and the Uniform Statewide Building Code (§ 36-97 et seq.).

HB 683 Status- Signed by Governor, Effective July 1, 2018

Support- This removes the requirement to keep house plans confidential.

Chief patron: Pogge

Uniform Statewide Building Code; security of certain records. Clarifies that while information contained in engineering and construction drawings and plans for any single-family residential dwelling submitted for the purpose of complying with the Uniform Statewide Building Code (§ 36-97 et seq.) or the Statewide Fire Prevention Code (§ 27-94 et seq.) shall not be subject to disclosure to the public under the Virginia Freedom of Information Act (§ 2.2-3700 et seq.), such information shall not be deemed confidential.

HB 714 Status- Continued to 2019 SB 784 Status- Died in committee (committee to send a letter recommending study)

Oppose- VA Wine Council bill. They have issues with the rigors of the building code when applied to rural areas. For instance sprinkler requirements in areas with no public water. They may carry this bill over and form a work group to study.

Chief patron: Bell 714, Obenshain 784

Uniform Statewide Bullding Code; Board of Housing and Community Development; provisions for buildings and structures in rural areas in which commercial enterprises are located. Directs the Board of Housing and Community Development to make amendments to the Uniform Statewide Building Code applicable to buildings and structures in rural areas in which commercial enterprises are located. The bill provides that the amendments shall not apply to any building or structure for which (i) a building permit has been issued or on which construction has commenced or (ii) working drawings have been prepared in the year prior to the effective date of the amendments. The bill also requires the Board to establish guidelines for the adequate training of building officials, enforcement personnel, contractors, and design professionals regarding Building Code provisions applicable to farm buildings and structures.

HB 732 Status- Signed by Governor, Effective July 1, 2018 SB 478 Status- Signed by Governor, Effective July 1, 2018

No Position-

Chief patron: Hodges

Department of Professional and Occupational Regulation; contractors; prohibited acts. Provides that a contract entered into by a person undertaking work without a valid Virginia contractor's license is unenforceable by such person. However, the bill also prohibits assertion of lack of licensure or certification as a defense to any action or suit if the unlicensed contractor gives substantial performance within the terms of the contract in good faith and without actual knowledge that a license or certificate was required.

HB 796 Status-Signed by Governor, Effective July 1, 2018

No position-

Chief patron: Hope

Zoning; disabilities. Requires a locality to give consideration to the need for reasonable modifications to requirements that are necessary to accommodate persons with disabilities when preparing a zoning ordinance. The bill also alters the standard by which a variance shall be granted by adding the phrases "including the safe and easy use thereof" in regard to property and "or would accommodate persons with disabilities as required under the Americans with Disabilities Act."

HB 859 Status- Signed by Governor, Effective July 1, 2018

Support- This is a VBCOA bill. This bill provides enabling legislation that allows localities to enter into mutual aid agreements with other localities to provide assistance with building code enforcement services.

Chief patron: Peace

Uniform Statewide Building Code; administration and enforcement; agreements for assistance between localities. Provides that the local governing body of a county or municipality may enter into an agreement with the local governing body of another county or municipality for the provision to such county or municipality's local building department of technical assistance with administration and enforcement of the Building Code.

HB 887 Status- Signed by Governor, Effective July 1, 2018

No position- See MOE between DHCD and VDH.

Chief patron: Orrock

Onsite sewage systems; maintenance. Provides that the adjustment or replacement of sewer lines, conveyance lines, distribution boxes, or header lines is considered maintenance of an onsite sewage system and thus does not require a permit. Under current law, adjustment and replacement of such equipment requires the system owner to obtain a permit.

HB 898 Status- Stricken in favor of HB164
SB 529 Status- Signed by Governor, Effective July 1, 2018 (amended to HB164 text)

Support with <u>HB 164</u> text- This is a Newport News bill. This version requires a known contractor be listed. What do you do if the contractor is not known at the time of application or it is owner contracted? We have been told that 898 will be stricken and 529 revised to be consistent with 164.

Chief patron: Yancey (H), Mason(S)

Board for Contractors; prerequisites to obtaining a building permit; elimination of affidavit requirement. Removes the requirement that a building permit applicant's written statement that he is not subject to

licensure or certification as a contractor or subcontractor be supported by an affidavit. The bill contains technical amendments.

HB 904 Status- Died in committee

No Position-

Chief patron: Robinson

Virginia Freedom of Information Act (FOIA); general exclusion for trade secrets submitted to a public body. Creates a general record exclusion for trade secrets submitted to a public body.

HB 1136 Status- Died in committee

Oppose- This bill is legislating the building code and the fire prevention code

Chief patron: Rasoul

Aboveground chemical storage tanks. Authorizes localities to adopt an ordinance that makes it unlawful for any person to construct, maintain, or use any aboveground chemical storage tank (ACST) having a capacity of 250 gallons or more without obtaining a permit from the local fire official. The penalty for violating the ordinance shall not exceed a Class 1 misdemeanor. The bill directs the Board of Housing and Community Development to adopt regulations requiring that the inspection, repair, alteration, or reconstruction of any such ACST comply with API 653 Standard or an appropriate equivalent standard for any tank too small to be governed by API 653.

HB 1192 Status- Died in committee

No Position

Chief patron: Cline

Administrative Process Act; development and periodic review of regulations; report. Requires all executive branch agencies to develop regulations in the least burdensome and intrusive manner possible and provides guiding principles for the development, adoption, and repeal of regulations. The bill also requires each agency to establish a schedule for the review of all regulations for which the agency is the primary responsible agency.

HB 1224 Status- Continued to 2019 session

Support- This removes the farm exemption from wineries and breweries. They may carry this bill over and form a work group to study.

Chief patron: Hugo

Uniform Statewide Building Code; applicability to farm buildings and structures. Provides that the current exemption for farm buildings and structures from the Uniform Statewide Building Code does not apply if a building or a portion of a building is operated as a licensed winery or farm winery or brewery under the provisions of the Alcoholic Beverage Control Act (§ 4.1-100 et seq.). The bill has a two-year delayed effective date to allow existing structures to come into compliance with the Uniform Statewide Building Code.

HB 1290 Status- Died in committee

Support- Allows drone use without a warrant.

Chief patron: Guzman

Tethered unmanned aircraft systems. Allows a law-enforcement agency or other state or local agency having jurisdiction over criminal law enforcement or regulatory violations to deploy a tethered unmanned aircraft system without obtaining a search warrant, provided that the person with legal authority over the property upon which the aircraft system is tethered consents to the deployment and the property is posted as being under surveillance by a tethered unmanned aircraft system.

HB 1340 Status- Died in committee

Oppose- What happens if the inspection results require permits and work? How does the building official determine if it is a small business? I very large disasters 15 days may not be enough time. What about FEMA?

Chief patron: Bloxom

Emergency services and disaster law; expedited inspections required for small businesses. Provides that in the event that a small business has been impacted by a disaster for which the Governor has declared a state of emergency, any agency of state or local government responsible for conducting inspections for compliance with minimum established standards for health and safety shall conduct any such inspections as are required for the small business to resume normal business operations within 15 days of receipt of a request for an inspection made by such small business. The bill defines "small business" as an independently owned and operated business that, together with affiliates, has 250 or fewer employees or average annual gross receipts of \$10 million or less averaged over the previous three years.

HB 1476 Status- Stricken

Oppose- Legislating the building code. Del. Hope does want the discussion of this issue to continue at the regulatory level.

Chief patron: Hope

Uniform Statewide Building Code. Directs the Board of Housing and Community Development to amend the Uniform Statewide Building Code (§ 36-97 et seq.) to require the installation of arc fault circuit interrupter protection for detached one-family and two-family dwellings and townhouses pursuant to the International Residential Code and in compliance with the requirements of the National Electrical Code.

HJ 13 Status- Died in committee

No Position- This bill was submitted in 2017 and died in the House rules committee.

Chief patron: Yancey

Encouraging localities to develop a more uniform and streamlined permitting process. Expresses the sense of the General Assembly that localities be encouraged to develop a more uniform and streamlined permitting process. Such an effort would benefit from having the Virginia Association of Counties and the Virginia Municipal League take the lead in developing a model application and permitting process while utilizing the best practices from localities throughout the Commonwealth.

HJ 26 Status- Passed House/Senate

HJ 27 Status- Died in committee

SJ 19 Status- Continued to 2019

No Position- These bills continue the study of coastal flooding. HJ 27 calls for a JLARC study.

Chief patron: H-Stolle, S-Locke

HJ 26-Study; continuing the Joint Subcommittee on Coastal Flooding; report. Continues the Joint Subcommittee on Coastal Flooding for two additional years, through the 2019 interim. HJ 27 calls for a JLARC study.

SB 173 Status-Continued to 2019

No Position- This creates a new chapter 10 in title 27 that covers permits for sale of consumer fireworks.

Chief patron: Stanley

Regulation of the sale and use of consumer fireworks; criminal and civil penalties. Authorizes a person to sell consumer fireworks, defined in the bill, if he possesses a federal permit to sell fireworks, a permit issued by the Virginia Fire Services Board, and a local permit, if and as required by the locality where the sales facility is located.

SB 186 Status- Signed by Governor, Effective July 1, 2018

Support-.

Chief patron: Black

Unmanned aircraft by a locality; search warrant; exception. Authorizes local government department to utilize an unmanned aircraft system without a search warrant when such system is utilized to support any locality for a purpose other than law enforcement such as damage assessment.

SB 199 Status- Died in committee

No Position-.

Chief patron: DeSteph

Rights of persons with disabilities; procedures for certain actions; notice and opportunity to cure. Provides that before bringing a civil action based on the failure to remove an architectural barrier, as defined in the bill, to access into an existing public accommodation, the aggrieved person shall provide to the owners or operators a written notice...

SB 201 Status- Died in committee

No Position-.

Chief patron: Favola

Regulations governing hospitals; facilities performing abortions. Removes language classifying facilities that perform five or more first trimester abortions per month as hospitals for the purpose of complying with regulations establishing minimum standards for hospitals.

SB 460 Status- Died in committee with letter to DPOR to address

No Position-

Chief patron: Stanely

Professions and occupations; home inspectors; assertion as to presence or absence of radon. Provides that no home inspector shall make any assertion as to the presence or absence of radon, or amount thereof, in a residential building, nor conduct or offer to conduct any radon screening or testing, unless he (i) is listed as a

professional by either the National Radon Proficiency Program or the National Radon Safety Board or (ii) meets any other proficiency measures deemed acceptable by the U.S. Environmental Protection Agency or the Board of Health for the purpose of offering such screening or testing, and otherwise complies with additional requirements contained in Title 32.1 (Health).

SB 488 Status- Died in committee

HB 1411 Status- Passed by indefinitely (Died) at request of patron

HB 1420 Status- Stricken from docket at request of patron

Oppose- This is the same bill from last session to move the SFPC to the Fire Services Board. The FSB is not a regulatory board, it is a fire service special interest board that was created to perform an advisory role. The Board of Housing is a citizens board, which is necessary to promulgate regulations imposed on the citizens.

Chief patron: Edwards (488), Helsel (1411), Collins (1420)

Statewide Fire Prevention Code; powers and duties of the Virginia Fire Services Board. Transfers primary authority for the adoption of the Statewide Fire Prevention Code from the Board of Housing and Community Development to the Virginia Fire Services Board (the Board). The bill allows the Board to convene an ad hoc committee whenever it proposes a change to the Statewide Fire Prevention Code for the purpose of advising the Board. The bill also requires the Board to develop the means to publicize the policies and programs of the Department of Fire Programs to educate the public and elicit public support. The bill contains technical amendments.

SB 778 Status- Died in committee

No Position-

Statewide Fire Prevention Code; State Fire Marshal; consumer fireworks; penalties. Authorizes the use of consumer fireworks in the Commonwealth and distinguishes by definition consumer fireworks from display fireworks and permissible fireworks.

SB 921 Status- Signed by Governor, Effective July 1, 2018 (amended to HB683 text)

Support- This is an Alexandria bill to allow citizens to view the exterior elevations of homes that they have a planning and zoning concern with, or that are subject to a zoning or building code appeal.

Uniform Statewide Building Code; security of certain records. Provides that the exemption from disclosure of information contained in engineering and construction drawings and plans for any single-family residential dwelling submitted for the purpose of complying with the Uniform Statewide Building Code (§ 36-97 et seq.) or the Statewide Fire Prevention Code (§ 27-94 et seq.) is limited to information that includes a depiction of the interior of a structure. The bill also provides that nothing shall be construed to exempt from disclosure or deny public access to any engineering and construction drawings and plans for any single-family residential dwelling that (i) depict only the exterior of the single-family residential dwelling or (ii) are the subject of an appeal to the Board of Zoning Appeals, the Board of Building Code Appeals, or any other administrative board.

SJ 53 Status- Died in Committee

Support-

Chief patron: Deeds

Study; Virginia Housing Commission; accessory dwelling structures; report. Directs the Virginia Housing Commission to study accessory dwelling structures, defined as additional living quarters on single-family dwelling structures that are independent of the primary dwelling unit. In conducting the study, the Commission is to review (i) the prevalence and necessity for accessory dwelling structures, (ii) relevant provisions of the Uniform Statewide Building Code, and (iii) the feasibility of changing land use and zoning practices in order to facilitate their expanded use. The bill also directs the Commission to make recommendations concerning the use and placement of accessory dwelling structures.
